CHILD RIGHT PROMOTION AND PROTECTION

CHILD PROTECTION CASES MANAGED AT THE OFFICE

During the period under review, a total of twenty-three (23) child and family related cases were received. Twelve (12) cases were successfully treated at the agency level. Nine (9) of the cases were referred and the remaining pending (2) cases are pending. Out of the twenty-three (243cases, there were a total of fifty-three (53) children involved in the cases of which thirty (30) were boys and twenty-three (23) were girls.

Of these cases, three cases were received from the Domestic Violence and Victims Support Unit of the Ghana Police Service. The table below is a summary of cases and the number of children involved;

FREE NHIS REGISTRATION AND RENEWAL FOR INDIGENTS

As part of the efforts to ensure good health for all vulnerable persons including Persons with Disability (PWDs) in the Municipality, a total of One Thousand Four Hundred and forty (1440) persons were supported to either register or renew their NHIS cards in order to access health free of charge.

Out of the total number, Six Hundred and Ninety-Eight (698) were males and Seven Hundred and Forty-Two (742) were females.

As at the time of preparing this report, three (3) PWDs had been registered. This was due to outsourcing registration to the disability associations at the community levels. This move is very beneficial to persons with disability and is planned to be upheld.
